▶ Article 7.0 Election, Removal and Replacement of EATA Officers

**Proposed Amendment of Bylaw:**

"7.1 Nominations and Elections

A. A list of nominees shall be established by the Nominations and Elections Committee by **September 1st** prior to the annual meeting."

**AJ Duffy makes motion to approve "Article 7.1 – A" Amendment Bylaw Date Change. Seconded: Charlie Thompson Vote: Passed Unanimously**

**Current Bylaw:**

"B. Elections shall be conducted on or before November 1<sup>st</sup> by mail or electronic medium with all ballots being postmarked by December 10<sup>th</sup>. Ballots will be counted by December 15<sup>th</sup> and no ballot will be counted after that date regardless of postmark. The candidate receiving the *majority* of the ballots shall be declared the winner. *In the event there are more than two candidates, preferential ballots as described by Robert's Rules of Order will be utilized.* "

**Proposed Amendment of Bylaw:**

"B. Elections shall begin on **September 15th by electronic medium. Voting will end on October 7<sup>th</sup>**. The candidate receiving the *majority* of the ballots shall be declared the winner. *In the event there are more than two candidates, preferential ballots as described by Robert's Rules of Order will be utilized.CC."*
